Categories in the 2022 Pilbara Community Services Excellence Awards

The Award categories and eligibility for each category are outlined below. You can enter more than one category as long as you meet the eligibility criteria for each category. You need to do a separate nomination for each category.

You can self-nominate or be nominated by someone else. We encourage the community to get involved and nominate an amazing individual and/or organisation who you feel should be acknowledged and celebrated for the services and support they provide to your community.

Award Category	Awards Description and Eligibility Criteria
Most Outstanding Small Organisation	The organisation must employ fewer than 5FTE or equivalent staff members
	An organisation that has made an outstanding positive and lasting difference to their community through the programs and services it delivers.
Most Outstanding Medium Organisation	The organisation must employ between 5-15 FTE or equivalent staff members
	An organisation that has made an outstanding positive and lasting difference to their community through the programs and services it delivers.
Most Outstanding Large Organisation	The organisation must employ more than 15 FTE or equivalent staff members
	An organisation that has made an outstanding positive and lasting difference to their community through the programs and services it delivers.
Best Pilbara Organisation	The winner of each of the above three categories will be put forward as finalists for this category
Outstanding Demonstration of Primary Health Care Collaboration and Partnership for Improved Healthcare and Wellbeing in	This award is open to any organisation based in the Pilbara.
the Pilbara	An organisation that has demonstrated commitment to improving primary health place-based outcomes for their community.
People's Choice Awards	Awarded to the organisation with the most public votes. The organisation must have nominated in any of the organisation categories to be eligible.
DREAM Award	This award is open to any organisation based in the Pilbara.
	An organisation that demonstrates innovation and creative thinking. A new or re-designed service or program to meet identified needs in the community.



ENGAGE Award	This award is open to any organisation based in the Pilbara.
	An organisation that demonstrates partnership and collaboration. Creating place-based partnerships to meet identified needs in the community.
OVERCOME Award	This award is open to any organisation based in the Pilbara.
	An organisation that demonstrates resilience and determination. Ability to adapt to challenges to ensure continuity of quality services to the community, especially during the pandemic.
INSPRIRE Awards	
Inspirational Young Person	This award is open to any young person aged 10-25 years old.
	Someone who has inspired others through leadership, determination and commitment and achieved positive outcomes for their community.
Inspirational Senior	This award is open to anyone aged 50 years and over.
	Someone who has inspired others through leadership, determination and commitment and achieved positive outcomes for their community.
Inspirational Community Hero	This award is open to any individual in the community who volunteers their time to help others.
	Someone who has inspired others and gone above and beyond to make a significant contribution and achieve positive outcomes for their community.
Inspirational Indigenous Leader	This award is open to any Indigenous person.
	Someone who has inspired others through leadership, determination and commitment and achieved positive outcomes for their community.

To be eligible to nominate for the 2022 Pilbara Community Services Excellence Awards you must meet the following criteria:

- ** Be Pilbara based and working/volunteering in the Community Services Sector.
- Have been in operation for at least 12 months prior to your nomination.
- * Meet the Eligibility Criteria above for your nominated category.



Nomination Process

Stage one - Complete a nomination form

- 1. Ensure you meet the eligibility criteria for your chosen Award Category.
- 2. Complete a nomination form for your chosen Award Category. This can be done on survey monkey https://www.surveymonkey.com/r/PCSEA2022 or completing and emailing the nomination form below to pilbara4purpose@gmail.com
- 3. Ensure you complete a separate nomination form for each category you wish to nominate for.
- 4. Ensure you provide one referee and let them know they may be contacted about the nomination.
- 5. Ensure you provide contact information for the nominee and let them know they may be contacted about the nomination.
- 6. Ensure you address the selection criteria and provide as much information as possible to demonstrate outcomes achieved for the community and to tell your story. Attach supporting documentation and feel free to email additional information through if needed.

Stage Two - Nominee and Referee contacted to provide additional supporting information

- 1. The nominee and referee may be contacted by P4P to confirm information on the nomination
- 2. The nominee may be asked to provide additional supporting information relevant to the Award category they have been nominated for.

The nomination process will close on 22nd July 2022.
